If you are applying for a licence, SOCAN will process your application within 30 days of receipt and contact you in the event that your application is not approved. If you already have a licence under SOCAN Tariff 15.B, this is your annual report.

A Tariff 15.B licence gives you the right to communicate *Works* over a telephone while a caller is on hold.

Where fees are paid under Tariff 16, no fees shall be payable under Tariff 15.B. Please contact us if you have other music uses. You may need to be licensed under other tariffs.

1. If the tariff for a year has not been approved by January 1st of that year, the last approved tariff will govern until the new version is approved, at which time the annual licence fees will be adjusted to reflect the approved version for the year.

3. This licence will renew automatically on January 1st of the following year for a 12-month period unless terminated by either party upon 30 days notice in writing.
4. The licence fee, plus applicable taxes for the year, will be calculated in accordance with the terms of the tariff based on the information set out in the most recently filed report form or audit form, subject to adjustment to reflect any updated reports or audits pursuant to the tariff.
5. You will keep records of all information required to calculate the licence fees for each year.
6. Licence fees and report forms are due on or before January 31st of the year covered by the licence or within 10 days of any adjustments.
